DISSERTATION

My dissertation centers around questions about essence, explanation and kind-membership. In the first chapter of my dissertation, I argue that we should not use essence to define ontological dependence. The essentialist definition suffers the same problem that faces the modal definition of dependence: it is insensitive to the direction of particular instance of dependence. In the second chapter I propose a notion of propria inspired by Aristotle, on which propria are non-essential, necessary properties explained by the essence of a thing. My proposal differs from the characterization of propria by Kit Fine and Kathrin Koslicki: unlike Fine, the relation of explanation on my account can't be assimilated to a notion of logical entailment. In disagreement with Koslicki, I suggest that the explanatory relation at issue needs not be necessary. My account of essence is conceptually parsimonious: it illuminates the contribution of essence to explanation without relying on obscure notions such as Aristotelian form or identity. In the third chapter, I defend a one-thinger view of material constitution, on which an object can be members of distinct kinds at the same time by bearing different similarity relations to different entities in the same world. I argue that the multithinger's argument for coincidence based on non-modal, sortalish differences between the constituted entity and its constituting matter is invalid, due to different usages of names such as "Goliath" and "Lumpl" across the argument. Further, I offer a metaphysical picture of how a single object can possess conflicting sortalish properties.
